- All competition entries must adhere to the Rules of the Australian Kinesiology Association Inc., the AKA Inc. Professional Conduct and Practice Rules and the AKA Inc. Code of Ethics. Some of this information has been listed here for you, but we do ask that you familiarise yourself with these documents.
